- 2. In a home with a licensed bed capacity of more than 64 but fewer than 97 beds,
at least 24 hours per week. O. Reg. 79/10, s. 212 (1).**
- 3. In a home with a licensed bed capacity of 97 beds or more, at least 35 hours per
week. O. Reg. 79/10, s. 212 (1).**

Findings/Faits saillants :



1. The licensee failed to ensure the home's Administrator worked regularly in that position on site at the home at least 35 hours per week.

A Compliance Order was previously issued for this non-compliance on June 5, 2015 and a Written Notification was issued previously for this non-compliance on February 3, 2014.

It was confirmed by the Chief Executive Officer/Administrator that the Administrator of the home still held dual responsibility for the administration and the overall responsibility for two 120 bed long term care homes including Faith Manor. The Administrator confirmed that this dual role allowed approximately 20-25 hours per week dedicated to the administration of Faith Manor and confirmed that this did not meet the legislative requirement of a minimum of 35 hours per week in a home with a licensed bed capacity of 97 beds or more. The Chief Executive Officer/Administrator confirmed that the home did not comply with the order previously issued on June 3, 2015.

The home submitted a plan of corrective action to the Director on June 29, 2015, which outlined the home's plan for re-structuring the policy and job description of the Administrator and stated that "consideration would be given to a change of roles upon the recruitment of a replacement". An interview with the home's new Chief Executive Officer/Administrator confirmed that they were hired in December 2015 and that no changes to the role and responsibilities of the Administrator had been made thus far. The Chief Executive Officer/Administrator confirmed that the home was currently creating a plan for re-structuring and had hired an external service provider for the recruitment of a full time on site Administrator for their sister home, but that no changes have been made to the current Administrative role.
