During the course of the inspection, the inspector(s) spoke with the Vice President of St. Joseph's hospital, St. Mary's hospital team member, the Director of Long-term Care St. Joseph's, the National Director of Operations (Revera), the Acting Director of Operations (Revera), the Executive Director (ED), the Director of Care (DOC), the Nutrition Manager (NM), a Registered Dietitian (RD), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Behaviour Supports Ontario (BSO) Personal Support Workers (PSWs), PSWs, Dietary Aides, Housekeepers, Personal Support Aides (PSAs), a Cook, family members and residents.
