**The purpose of this inspection was to conduct a Critical Incident System inspection.**

**This inspection was conducted on the following date(s): April 14, 2021 (on site) and April 15, 16, 20, 21, 22, 23, 2021(offsite)**

**During the course of this inspection the following logs were inspected: Log # 016524-20, Critical Incident (CI) #2746-000008-20, log # 0232664-20, CI #2746-000010-20 and log # 025336-20, CI #2746-000011-20 related to an incident that caused an injury to a resident for which the resident was taken to the hospital and which resulted in a significant change in the resident's health status.**

**During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the Assistant Director of Care (ADOC), the Infection and Control Nurse, the Environmental Supervisor, one Registered Nurse (RN), one Registered Practical Nurse (RPN), several Personal Support Workers (PSWs), one COVID-19 Screener and several residents.**

**During the inspection, the IPAC Observation Checklist and observation of care and services provided to residents were completed. The residents health care records and investigation notes related to the incidents were reviewed.**
