The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): August 13, 14, 15, 16, 2013

During the course of the inspection, the inspector(s) spoke with Administrator, Director of Care, Assistant Director of Care, Registered Nurse, Registered Practical Nurse, Personal Support Worker, Housekeeping Aide, Maintenance Manager, Physiotherapist, Occupational Therapist, Capital Pest Control Manager, President of the Resident's Council Committee and several Residents.

During the course of the inspection, the inspector(s) reviewed the resident's health care record, the home's critical incident reports and interventions, Housekeeping and Maintenance log book, the home's Minimal/Zero lift policy, Transfer/Lift, Repositioning and Health Safety staff in-service attendance in March 2013, Hospital Emergency reports, Pest Control Company Service Agreement and reports, the home's Satisfaction Survey 2013, the home's correspondence to the complainant, observed several residents rooms and observed the identified resident's activities.
