The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): February 28 - March 2, 2017.

This Follow Up Inspection is related to the home not training all staff in their revised neglect and abuse policies, and in the areas of residents' rights, mandatory reporting and whistle-blowing protection.

A Complaint Inspection #2017_509617_005 and Critical Incident Inspection #2017_509617_004 were conducted concurrently to this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator/Chief Nursing Officer, Nurse Manager, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Education Coordinator, Recreational Aid, Support Services Staff (Housekeeping and Dietary), residents, and their family members.

The Inspector conducted a daily walk through of resident areas, observed the provision of care towards residents, observed staff to resident interactions, reviewed residents' health care records, staff training records, policies, procedures, programs, and staff personnel files.
