**The purpose of this inspection was to conduct a Critical Incident System inspection.**

**This inspection was conducted on the following date(s): November 17, 18, 19, 23, and 26, 2020.**

**The following intakes were inspected as part of this Critical Incident System inspection:**

**log #016953-20, log #018445-20, log #019026-20, and log #019325-20, all related to a fall of a resident, and log #022887-20, related to a medication incident.**

**A Follow-up inspection under log #023675-19 with respect to resident responsive behaviours was also conducted.**

**During the course of the inspection, the inspector(s) spoke with the Administrator, Behavioural Supports Ontario (BSO) worker, the Director of Care, the Nurse Practitioner, personal support workers, registered practical nurses, the Staff Development/Infection Control Officer, and the Supervisor of Resident Services - Nursing.**

**The inspector reviewed a responsive behaviour policy, reviewed resident health care records, observed residents, and observed residents' environments.**

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 49. Falls prevention and management**

**Specifically failed to comply with the following:**

**s. 49. (2) Every licensee of a long-term care home shall ensure that when a resident has fallen, the resident is assessed and that where the condition or circumstances of the resident require, a post-fall assessment is conducted using a clinically appropriate assessment instrument that is specifically designed for falls. O. Reg. 79/10, s. 49 (2).**

**Findings/Faits saillants :**

1. The licensee has failed to ensure that when a resident has fallen, that a post-fall assessment is conducted using a clinically appropriate instrument that is specifically designed for falls.

Resident #003 and resident #004 each suffered a fall with injury on specific dates. A post-fall assessment using a clinically appropriate tool was not completed for either fall.
