**The purpose of this inspection was to conduct a Critical Incident System inspection.**

**During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Resident Care Supervisors, Infection Control Lead, Manager for Environmental Services, Social Worker, a Registered Practical Nurse (RPNs), several Personal Support Workers (PSWs), Resident Care Aides (RCAs), housekeeping staff, and a resident.**

**During the course of the inspection, the inspector(s) observed the provision of resident care, observed a lunch time meal services, observed infection control practices, observed availability of Personal Protective Equipment (PPEs), reviewed the licensee's "Pandemic Playbook", dated June 2020 and policy "Essential Caregiver Visits During COVID-19", revised November 23, 2020 as well as reviewed the Cornwall Community Hospital Infection Control and Prevention Assessment of May 8, 2020 and the Eastern Ontario Health Unit Infection Control and Prevention Assessment of January 4, 2021.**
