**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 8.
Nursing and personal support services**

Specifically failed to comply with the following:

s. 8. (3) Every licensee of a long-term care home shall ensure that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations. 2007, c. 8, s. 8 (3).

Findings/Faits saillants :

1. The licensee failed to ensure that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations.

Interview and record review confirm that on Saturday November 30, 2013 the home failed to have at least one Registered Nurse on duty and present in the home for the day shift.

Interview confirms that the home did not comply with the criteria identified under 24-hour nursing care - exceptions identified in O.Reg 79/10 s. 45(2)(ii) on Saturday November 30, 2013. [s. 8. (3)]
