The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): July 16 and 17, 2015.

This Inspection Report is as a result of Continuous Quality Improvement activity conducted at the Hamilton Service Area Office.

During the Resident Quality Inspection (RQI), Inspection Number 2015-323130-004, Log Number H-001830-15, dated May 11, 2015, the Inspectors identified that the home was in compliance with previously identified Compliance Orders (CO's), O. Reg 79/10 s. 72(3)a, from Inspection Number 2014-312503-0026 and O. Reg 79/10 s. 77(1), from Inspection Number 2014-343585-0022.

The identified RQI Report did not include the previously identified CO's as complied with.

The purpose of this Inspection Report is to return O. Reg 79/10 s. 72(3)a and 77(1) to compliance.

During the course of the inspection, the inspector(s) spoke with the Administrator and Inspectors who conducted the RQI (Inspection Number 2015-323130-004 - Log Number H-001830-15).
