Log #015185-17 - LTCHA 2007, c. 8, s. 101(4) related to conditions to which the licensee is subject, from Inspection 2007_569508_0007.

Non-compliance in relation to follow-up log #015187-17 was identified while conducting concurrent Critical Incident inspection (CIS) #2018_587129_0004. Specifically, while inspecting CIS log #009123-17 (CIS 2741-000014-17), #017547-17 (CIS 2741-000028-17) and #012762-17 (CIS 2741-000020-17) it was identified that the home was not in compliance with LTCHA 2007 s. 19(1).

Non-compliance related to LTCHA 2007 s. 19(1) was issued as a compliance order during CIS Inspection #2018_587129_0004, which was conducted concurrently with this Follow-up Inspection.

(PLEASE NOTE: Previously issued CO related to LTCHA 2007 s. 19(1) was not “closed with link” when this section was re-issued on CIS Inspection Report #2018_587129_0004 and in order to generate this Follow-Up Inspection report the previously issued CO related to s. 19(1) was identified as “complied”.

During the course of the inspection, the inspector(s) spoke with residents, Maintenance Manager, Administrator, Assistant Administrator, Personal Support Workers, housekeeping staff and a laundry aide.

During the course of the inspection the inspector toured all three home area floors, randomly tested the resident-staff communication and response system for function, reviewed completed monthly inspection audits of the system, how staff reported any malfunction to the system and follow-up actions taken. A review of laundry staffing was also completed.
