WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect

Specifically failed to comply with the following:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants :



1. The licensee has failed to ensure that resident #002 was protected from abuse by resident #001.

A) On a date in May 2015, a witness observed an incident when resident #002 sustained injury in an altercation with co-resident #001. According to the health records, there were previous incidents of the resident's responsive behaviours against co-residents but no injuries had been sustained.

The above information was confirmed by the health records, critical incident report, staff and the DOC.

Despite the observed and documented increasing frequency of resident #001's aggressive behaviours toward other residents, the home failed through inaction to protect resident #002 from physical abuse.

Additional Required Actions:

CO # - 001 will be served on the licensee. Refer to the "Order(s) of the Inspector".

**WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**



Specifically failed to comply with the following:

- s. 6. (4) The licensee shall ensure that the staff and others involved in the different aspects of care of the resident collaborate with each other,**
- (a) in the assessment of the resident so that their assessments are integrated and are consistent with and complement each other; and 2007, c. 8, s. 6 (4).**
- (b) in the development and implementation of the plan of care so that the different aspects of care are integrated and are consistent with and complement each other. 2007, c. 8, s. 6 (4).**

Findings/Faits saillants :

1. The licensee failed to ensure that the staff and others involved in the different aspects of care of the resident collaborated with each other, (a) in the assessment of the resident so that their assessments were integrated and were consistent with and complemented each other

A) The current written care plan for resident #002 indicated that the resident was at a low risk for falls. However, the falls assessment completed by registered staff in May 2015 indicated that resident #002 was at a high risk for falls. The assessments were not consistent with each other or collaborative. This was confirmed by the Quality Assurance nurse and the DOC. [s. 6. (4) (a)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the staff and others involved in the different aspects of care of the resident collaborate with each other, (a) in the assessment of the resident so that their assessments are integrated and are consistent with and complement each other, to be implemented voluntarily.

WN #3: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records



Specifically failed to comply with the following:

- s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,**
- (a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and O. Reg. 79/10, s. 8 (1).**

Findings/Faits saillants :

1. The licensee failed to ensure that, where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the plan, policy, protocol, procedure, strategy or system, (b) was complied with.

According to the home's policy 11-1.11.1 entitled "Falls Prevention and Management Program", staff are not to move a resident who has fallen if there is suspicion or evidence of injury until a full head to toe assessment has been conducted.

The progress notes of resident #002 indicated that the staff moved and stood resident #002 up to the resident's feet after a witnessed fall but the resident was unable to bear weight. The resident complained of pain and had sustained injury. The Quality Assurance nurse, registered floor staff, the health record, the PSW who assisted the resident and the DOC confirmed that the staff did not follow the policy when they attempted to stand resident #002. [s. 8. (1) (b)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that, where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the plan, policy, protocol, procedure, strategy or system, (b) is complied with, to be implemented voluntarily.

WN #4: The Licensee has failed to comply with O.Reg 79/10, s. 53. Responsive behaviours

Specifically failed to comply with the following:

s. 53. (2) The licensee shall ensure that, for all programs and services, the matters referred to in subsection (1) are,

(a) integrated into the care that is provided to all residents; O. Reg. 79/10, s. 53 (2).

(b) based on the assessed needs of residents with responsive behaviours; and O. Reg. 79/10, s. 53 (2).

(c) co-ordinated and implemented on an interdisciplinary basis. O. Reg. 79/10, s. 53 (2).

s. 53. (4) The licensee shall ensure that, for each resident demonstrating responsive behaviours,

(a) the behavioural triggers for the resident are identified, where possible; O. Reg. 79/10, s. 53 (4).

(b) strategies are developed and implemented to respond to these behaviours, where possible; and O. Reg. 79/10, s. 53 (4).

(c) actions are taken to respond to the needs of the resident, including assessments, reassessments and interventions and that the resident's responses to interventions are documented. O. Reg. 79/10, s. 53 (4).

Findings/Faits saillants :



1. The licensee has failed to ensure that, for all programs and services, the matters referred to in subsection (1) are, (c) co-ordinated and implemented on an interdisciplinary basis.

A. The home's responsive behaviour program, specifically Policy 35-1.2 entitled "Risk Management the Defensive Resident: Gentle persuasive Approach", encouraged staff to use all available outside resources to assist with behaviour management.

Resident #001's health record indicated that the resident had demonstrated aggressive responsive behaviours toward co-residents on five occasions prior to a May 2015 incident when a co-resident sustained injury.

According to registered staff and the health record, the home did not attempt to utilize outside resources such as Behavioural Support Services to assist with the management of resident #001's abusive behaviours since the resident transitioned to the home in October 2014. [s. 53. (2) (a)]

2. The licensee failed to ensure that when resident #001 was demonstrating responsive behaviours, (c) actions were taken to respond to the needs of the resident, including assessments, reassessments and interventions and that the resident's responses to interventions were documented.

A) Resident #001's health record indicated that the resident had demonstrated aggressive responsive behaviours toward resident #002 on a date in April 2015. No specific interventions or actions were added to resident #001's plan of care to manage the behaviours after the April 2015 incident, such as regularly timed monitoring, medication addition or adjustment or referral to available outside resources. This information was confirmed by the health record and registered staff. [s. 53. (4) (c)]
