The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): December 13, 14 and 17, 2018

The following intake was completed in this Follow Up Inspection: Log #015366-18, which was related to bed rails.

During the course of the inspection, the inspector(s) spoke with the Director of Care, the Project Manager, the Resident Care Coordinator, the Maintenance Supervisor, the RAI Coordinator, Personal Support Workers, and residents.

During the course of the inspection, the Inspector observed identified residents in their beds with bed rails in use and observed the Maintenance Supervisor demonstrate entrapment zone testing on three identified beds. As well, the Inspector reviewed documentation related to entrapment zone testing, and reviewed identified residents health care records including assessments related to bed rail use.
