Four Critical Incident (CIS) intakes were inspected. Log #'s 020660-17, 027010-17, 024524-18 and 033601-18, related to hospitalization and significant change in condition.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Registered Nursing Staff, Personal Support Workers (PSW) and residents.
