Non-compliance was found during this inspection and was **remedied** by the licensee prior to the conclusion of the inspection. The inspector was satisfied that the non-compliance met the intent of section 154 (2) and requires no further action.

During a lunch meal in the dining room, staff #103 and staff #104 removed used dishes and uneaten food from one resident, then fed or served food to a second resident without performing hand hygiene in between.

After the writer spoke to the two staff members regarding the lack of hand hygiene, both immediately cleaned their hands.

The Infection Prevention and Control (IPAC) Lead #101 indicated that it is the expectation and part of the home's hand hygiene program that staff clean their hands after clearing used dishes and before serving food.

During subsequent meal service observations, all staff, including staff #103 and staff #104 cleaned their hands between removing used dishes and serving food to other residents.
