WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 36. Every licensee of a long-term care home shall ensure that staff use safe transferring and positioning devices or techniques when assisting residents. O. Reg. 79/10, s. 36.

Findings/Faits saillants:

1. The licensee failed to ensure that staff use safe transferring and positioning devices or techniques when assisting residents.

On the morning of April 18, 2012 two staff members failed to use safe technique when transferring Resident # 1 using a mechanical lift.

Staff interviews and record review indicate that a Personal Support Worker (PSW) and a Registered Practical Nurse (RPN) used a mechanical lift to transfer the resident from bed to chair while the resident was agitated. The RPN then proceeded to check the resident's blood sugar before the lift was removed from in front of the resident. As a result, the resident apparently hit the metal lift with his/her arm, causing part of the lift to swing back and strike his/her forehead, resulting in a small cut and extensive bruising to the left side of his/her face . First aid was provided and the resident was assessed by a Physician within the home.

The staff involved in the incident were subsequently disciplined, and received education in safe lifts and transfers. The resident's plan of care has been revised to include three staff members to assist during mechanical lifts.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that staff use safe transferring and positioning devices or techniques when assisting residents, to be implemented voluntarily.
