Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): February 10, 11, 15, 18, 22, 24, 2022 on site and February 23, 2022 off site.

This inspection was conducted in reference to intake log #017976-21, CIS #M537-000023-21, related to a resident having fallen resulting in an injury; intake log #001829-22, CIS #M537-000004-22, related to alleged resident to resident physical and verbal responsive behaviour; and intake log #020839-21, CIS #M537-000025-21 related to alleged resident to resident sexual assault.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Nursing, the Assistant Director of Nursing, Registered Nurses, Registered Practical Nurses, Personal Support Workers, and residents.

During this inspection the Inspector completed a tour of the home, observed residents' environments, the provision of care and services to residents, reviewed relevant resident health care records, and policies and procedures related to Zero tolerance of abuse and neglect, Infection Prevention and Control, Falls Prevention and Responsive Behaviours.
