Rationale and Summary:

On commencement of the inspection, the Director of Nursing (DON) indicated to the Inspector that they currently did not have an Infection Prevention and Control (IPAC) lead. They had recently hire someone who would be taking the position as IPAC lead starting later in May.

Not having an IPAC lead in the home posed an infection control risk to the residents.
