WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 78. Training and qualifications Specifically failed to comply with the following subsections:

s. 78. (1) Every licensee of a long-term care home shall ensure that food service workers hired on or after the day this section comes into force, other than cooks to whom section 76 applies, have successfully completed or are enrolled in a Food Service Worker program at a college established under the Ontario Colleges of Applied Arts and Technology Act, 2002 or a Food Service Worker program provided by a registered private career college and approved by the Superintendent of Private Career Colleges under the Private Career Colleges Act, 2005. O. Reg. 249/10, s. 2.

## Findings/Faits saillants:

An identified employee worked 23 full shifts and 1 short shift in dietary without having successfully completed or being enrolled in a Food Service Worker training program. [r.78(1)].
