WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 15. Accommodation services Specifically failed to comply with the following subsections:

- s. 15. (2) Every licensee of a long-term care home shall ensure that,
- (a) the home, furnishings and equipment are kept clean and sanitary;
- (b) each resident's linen and personal clothing is collected, sorted, cleaned and delivered; and
- (c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair. 2007, c. 8, s. 15 (2).

## Findings/Faits saillants :

1. During lunch service the inspector observed the serving of the meal from the servery.

- It was noted during this time that there were several housekeeping issues that need to be addressed:
- the edges of the walls and under all of the cupboards and steam cart have a build-up of dirt and debris along them.
- the edges of the refrigerator and the back of the refrigerator have a build-up of dirt and debris.
- the pipes under the handwashing sink are dirty.
- the toaster is dirty.
- the switch on the steam cart is soiled and the stainless steel on and around the steam cart is dirty.
- the exterior of the microwave has old food on the bottom and walls. The interior of the microwave has food debris on the walls and tray. An old magic cup is sitting melted in the microwave.
- the folding accordian window that closes the servery from the dining room is soiled and dirty.
- the cambro cart has dirt and debris noted along the bottom and edges of the shelves with old food spills on the cart.

- it was noted that several lipped plates and some of the white china plates are stained and unappetizing and are still in use in the dining room.

# Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with ensuring that the servery area is kept clean and sanitary., to be implemented voluntarily.
