**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.  
Plan of care**

**Specifically failed to comply with the following:**

**s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).**

**Findings/Faits saillants :**

1. The licensee did not ensure that the care set out in the plan of care is provided to the resident as specified in the plan. October 30, 2013, the physician wrote a treatment order for one resident.
2. October 11, 2013 the resident's treatment was not completed as ordered by the physician before October 30, 2013. Two managers and one staff confirmed this.
3. Two managers stated during a Ministry inspection, the home was reviewing their processes to ensure the resident's treatment would be completed as ordered.
4. Three staff during a Ministry inspection and two managers during a telephone interview confirmed the resident's treatment ordered December 13, 2013 was not completed on that date.[s. 6. (7)]

**Additional Required Actions:**

**VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)  
the licensee is hereby requested to prepare a written plan of correction for  
achieving compliance to ensure that the care set out in the plan of care is  
provided to the resident as specified in the plan, to be implemented voluntarily.**
