**s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).**

**Findings/Faits sayants :**

1. A resident did not have a speech language pathologist assessment as ordered in the plan of care by the dietitian. The dietitian had to re-write the order over two months later before the order was implemented and the assessment was arranged.
