Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The licensee has failed to ensure that the care set out in the plan of care was provided to the resident as specified in the plan.

Record review identified that the family of an identified resident wished to be notified of all changes and concerns regarding health and safety.

Staff interview with a Registered staff agreed that documentation and notification to the resident's family as outlined in the care plan was not completed.

Staff interview with the Director of Care confirmed that it was the home's expectation that the care was provided to residents as set out in the plan of care. [s. 6. (7)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to provide the care set out in the plan of care to the resident as specified in the plan, to be implemented voluntarily.
