Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA).

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 3.  
Residents' Bill of Rights**

**Specifically failed to comply with the following:**

**s. 3. (1) Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:**

**9. Every resident has the right to have his or her participation in decision-making respected. 2007, c. 8, s. 3 (1).**

**Findings/Faits saillants :**

1. The licensee failed to ensure that a resident's right to have their participation in decision making respected.

The LEA confirmed that the resident was not asked if they wanted to participate in the upcoming election.

The resident stated that voting was very important to them. The resident stated that no one at the home had asked if they wanted to vote in the upcoming election. The resident confirmed that they would have voted if they had been given the opportunity.

A resident's Power of Attorney (POA) confirmed that they had given direction to the home, that the resident would not be participating in the upcoming election. The POA confirmed that the resident had not been consulted about their wishes, to vote in the election. Failing to have the resident right to participate in the decision making respected, impacts the resident's dignity and well being.
