## Findings/Faits saillants:

1. The licensee has not ensured the care set out in Resident #929's plan of care was provided as specified in the plan of care, specifically the doctors orders.

Resident #929 was identified at risk for constipation. The physician ordered the resident to receive specific interventions at specific times to prevent constipation. Resident #929 did not receive this as per their plan of care. This was confirmed by the documentation and the nursing staff.
