Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

- s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,
- (a) the planned care for the resident; 2007, c. 8, s. 6 (1).
- (b) the goals the care is intended to achieve; and 2007, c. 8, s. 6 (1).
- (c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).

Findings/Faits saillants:

1. The plan of care did not set out clear directions for the staff and others who provide direct care to the resident. The plan of care for resident #001 in effect in May, 2013 indicated the diet to be regular diet, regular texture with pureed meats, however, the latest diet order dated earlier in May, 2013 indicated the diet to be regular diet, regular texture with puree meat and puree vegetables. The most current RAP's (resident assessment protocol) at the time was the annual assessment from April, 2013 which indicated diet of regular texture with some meats minced. As a result, the resident received the incorrect texture of regular or minced during the lunch meal on a specified date in May, 2013 as confirmed by the Dietary Aide who served the resident. [s. 6.
