WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 103. Complaints — reporting certain matters to Director

(1) Every licensee of a long-term care home who receives a written complaint with respect to a matter that the licensee reports or reported to the Director under section 24 of the Act shall submit a copy of the complaint to the Director along with a written report documenting the response the licensee made to the complainant under subsection 101 (1). O. Reg. 79/10, s. 103 (1).

Findings/Faits saillants :

1. The licensee did not ensure a written complaint received regarding the care of a resident or the operation of the long-term care home was immediately forwarded to the Director.
The Director of Resident Care and the Chief Executive Officer confirmed that a complaint received in 2012 was not forwarded to the Director.
