**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 15.
Accommodation services**

Specifically failed to comply with the following:

- s. 15. (2) Every licensee of a long-term care home shall ensure that,**
(a) the home, furnishings and equipment are kept clean and sanitary; 2007, c. 8, s. 15 (2).
(b) each resident's linen and personal clothing is collected, sorted, cleaned and delivered; and 2007, c. 8, s. 15 (2).
(c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair. 2007, c. 8, s. 15 (2).

Findings/Faits saillants :

1. The licensee has failed to ensure that the home is maintained in a safe condition and in a good state of repair.

Observation on June 30, 2015, at 11:40a.m. revealed that the dining room floor on 2 Coombs had water damage and the floor was rippling. Maintenance staff were observed duct taping the floor to smooth out the ripples.

Interview with the ED revealed that a steam table in the 2 Coombs server had leaked and caused water damage to the dining room floor. Residents are still able to use the dining room. The ED confirmed that the 2 Coombs dining area is not being maintained in a safe condition and good state of repair and that the floors and serveries will be replaced in 4-6 weeks. The ED is aware that the expectation is for the home to be maintained in a safe condition and good state of repair. [s. 15. (2) (c)]

Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure that the home is maintained in a safe condition
and in a good state of repair, to be implemented voluntarily.***
