Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).**

**Findings/Faits sayants :**

1. On 02 June 2011 the inspector confirmed the following:

An identified resident was involved in a critical incident requiring transfer to hospital due to injury. The resident had been settled in bed but without all appropriate safety measures applied. The resident was found lying on the floor in his/her room sometime later.

A review of the resident's plan of care indicated he/she had an increased risk for falls/injury and that appropriate safety measures were required while the resident was in bed.
