WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 21. Every licensee of a long-term care home shall ensure that the home is maintained at a minimum temperature of 22 degrees Celsius. O. Reg. 79/10, s. 21.

Findings/Faits saillants :

1. The licensee has failed to ensure that the home is maintained at a minimum temperature of 22 degrees Celsius.

On an identified date, the Ministry of Health and Long-Term Care (MOHLTC) received a complaint that the resident's room was cold.

In an interview, the complainant stated that his/her family member's room was cold for a few days, and it was resolved the next day after MOHLTC received the complaint.

Record review of the task information sheets and interview with staff #100 revealed that requests to check the heating system of the above mentioned resident room were sent to the maintenance department on five identified dates, and the maintenance staff responded to each request on the same day. In addition, the contractor was contacted on the third day after receiving the first request, and the damaged parts for the actuator were replaced seven days later. Record review of an identified task information sheet revealed that the room temperature in the above mentioned resident room was 19.6 degrees Celsius on the date when MOHLTC received the complaint, and 22 degrees Celsius two days later.

On an identified date, the inspector and staff #100 toured the home and measured the air temperature with an infrared thermometer in different locations and randomly selected 19 resident rooms, included the above mentioned identified resident room, and observed the air temperatures in the family room, multi-purpose room, seven activity rooms and eight dining rooms were below 22 degrees Celsius.

In an interview, staff #100 acknowledged the home was not maintained at a minimum temperature of 22 degrees Celsius. [s. 21.]
