Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA).

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

#### **WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care**

**Specifically failed to comply with the following:**

**s. 6. (5) The licensee shall ensure that the resident, the resident's substitute decision-maker, if any, and any other persons designated by the resident or substitute decision-maker are given an opportunity to participate fully in the development and implementation of the resident's plan of care. 2007, c. 8, s. 6 (5).**

**Findings/Faits saillants :**

1. The licensee has failed to ensure that a resident's SDM was provided the opportunity to participate fully in the development and implementation of the plan of care.

The Ministry of Long-Term Care received a complaint related to the resident's care concerns and hospital transfer.

In an interview, the resident's SDM stated they were concerned that the resident was not transferred to hospital related to a change in their nutritional status.

A review of the resident's progress notes indicated that staff documented the resident had a change in nutritional status, and that the resident required a specific intervention.

Documentation and interviews confirmed that the home did not provide an opportunity for the family to fully participate in the development and implementation of the resident's plan of care related to the change in nutritional status and possible transfer to hospital.

The DOC acknowledged that the home should have contacted the family and held a team conference with the RD to discuss the resident's nutritional status during that period.

***Additional Required Actions:***

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the resident's SDM was provided the opportunity to participate fully in the development and implementation of the plan of care, to be implemented voluntarily.***
