Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 229. Infection prevention and control program

Specifically failed to comply with the following subsections:

s. 229. (4) The licensee shall ensure that all staff participate in the implementation of the program. O. Reg. 79/10, s. 229 (4).

Findings/Faits sayants :

1. Observations made in dining room on August 16, 2011 at lunch time revealed :

a) Dietary Aide had one gloved hand - clearing dishes and getting plate of food or show plates without any hand washing between tasks;

b) A Personal Support Worker was observed clearing soup bowls, taking the dishes to the dirty dish cart and no handwashing before continuing to feed another resident,

c) A Personal Support Worker was observed taking an empty soup bowl to dirty dish cart, mixing a cup of coffee for another resident, returning to the first resident with show plate and then obtained lunch meal. No handwashing observed during this time. The Personal Support Worker continued to cut the resident's chicken on a bun sandwich with a fork and her bare hand. She then picked up pieces of sandwich in her bare hands and handed the pieces to the resident to eat.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance , to be implemented voluntarily.
