During the course of the inspection, the inspector(s) spoke with Personal Support Workers (PSW), Registered Practical Nurses (RPN), Registered Nurses (RN), the Director of Care/Infection Prevention & Control (IPAC) lead, residents, a family member, the visit coordinator, a life enrichment aid, screening and housekeeping staff and the Administrator.
