The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): February 5, 2019

An inspection (2018-539120-0020) was previously conducted in May 2018, related to the knowledge and understanding of maintenance staff to monitor heating and air conditioning equipment in the home. A compliance order (#001) was issued three weeks later. For this follow up inspection, the conditions laid out in the compliance order have been addressed.

An inspection (2018-737640-0020) was previously conducted in June and July 2018, and a compliance order (#003) was issued related to the lack of preventive maintenance related to drain sanitation and drain fly control. For this follow up inspection, the conditions laid out in the order have been addressed.

During the course of the inspection, the inspector(s) spoke with the Administrator, Environmental Manager (EM) and Director of Care.

During the course of the inspection, the inspector toured the home, observed floor drains in various locations, reviewed air and water temperature logs, maintenance policies and procedures related to floor drains, pest control service reports and the EM qualifications and work experience.
