Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with the Acting Administrator, the Assistant Administrator, the Manager of Environmental Services, Registered Practical Nurses, Personal Support Workers, Housekeeping staff, Therapy/Activity staff, residents and a resident's family member.

During the course of the inspection, the inspector(s) reviewed 24 hour air temperature reports for a random selection of resident rooms and common areas throughout the home, invoices related to the insulation of windows and inspections of the Heating, Ventilation and Air Conditioning (HVAC) system in the home over the past 12 months, Residents' Council meeting minutes and the response from the home related to concerns from Residents' Council about air temperature in the home.

1. The licensee has failed to comply with O. Reg. 79/10, s. 21 in that the home is not maintained at a minimum temperature of 22 degrees Celsius.

A complaint was received stating that the air temperature in the home was cold, especially in the Winter months.

During an interview with the Assistant Administrator and the Manager of Environmental Services on October 9, 2012 they stated that the home had issues in the Winter of 2011/2012 with certain windows becoming covered in frost and some residents were complaining about the cold. They further stated that actions have been taken to improve insulation around windows and further actions are being considered such as insulation in other areas of the home. The Manager of Environmental Services stated that the home's system can generate current 24 hour temperature reports for each area in the home.

A random selection of resident rooms and common areas were selected throughout the home and their 24 hour temperature reports were reviewed.

The Assistant Administrator stated that each resident room/area in the home has it's own thermostat that has a range of 5 degrees Celsius. The mid-point of each resident room/area thermostat is set at 22 degrees Celsius which means that a room can be set anywhere from 19.5 to 24.5 degrees Celsius.

According to the home's system generated 24 hour air temperature reports the following was found:

- As of 0855 hours on October 10, 2012 a specified resident room was 21.3 degrees Celsius and was below 22 degrees Celsius for approximately 21 of the 24 hours on the report, reaching a low of 21.0 degrees Celsius.
- As of 0841 hours on October 10, 2012 a specified resident room was 21.6 degrees Celsius and was below 22 degrees Celsius for approximately 14 out of the 24 hours on the report, reaching a low of 21.4 degrees Celsius.
- As of 0856 hours on October 10, 2012 a specified resident room was 21.5 degrees Celsius and was below 22 degrees Celsius for the entire 24 hour period of the report, reaching a low of 20.6 degrees Celsius.
- As of 1556 hours on October 9, 2012, a specified resident room was 20.7 degrees Celsius and was below 22 degrees Celsius for the entire 24 hour period of the report, reaching a low of 19.5 degrees Celsius.
- As of 1558 hours on October 10, 2012 a specified resident room was 23.9 degrees Celsius, but was below 22 degrees Celsius for approximately 6 out of the 24 hours on the report, reaching a low of 21.5 degrees Celsius.
- As of 1557 hours on October 9, 2012 a sitting lounge in the home was 21.0 degrees Celsius and was below 22 degrees Celsius for approximately 15 of the 24 hours on the report, reaching a low of about 20.7 degrees Celsius.

Staff members #S100 and S101 confirmed that the residents in three of the specified rooms would not understand how to work their in-room thermostats to increase the temperature if they were cold. The thermostats in each of these three resident rooms were found to be in the lowest position indicating the temperature was set at 19.5 degrees Celsius.

The thermostat in another resident room was checked and observed to have the front cover taped shut and when opened was in the lowest position indicating it was set at 19.5 degrees Celsius. Staff member #S107 stated on October 9, 2012 she did not know why the front cover of this resident's thermostat would be taped shut. She also stated that residents on this unit do not often use the sitting lounge since it is quite cold.

During an interview with staff members # S105 and S106 on October 10, 2012 they indicated that they did not know why the thermostat in a specified resident room was taped shut and that this resident would likely only know to turn up the thermostat if he/she was told to.

Another specified resident was interviewed and stated that his/her room is often cold and that he/she does not find moving the thermostat up makes a difference in the room temperature. The resident further stated that due to the location of his/her room and the draft from his/her own window he/she finds it very cold.
