1. The licensee of the home did not ensure that the medical directive or order for oxygen for one resident was individualized to the resident's condition and needs. Three staff confirmed one resident was administered oxygen without review by the physician since July 31, 2012. Review of the resident health record confirmed the physician's order had not been reviewed and reordered since July 31, 2012. Review of the health record information was confirmed by two staff. [s. 81.]
