Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff.

Findings:

1. May 13, 2011 through a chart review, a staff interview and resident interview it was confirmed that on [REDACTED] one resident pounded another resident's hand resulting in pain for the second resident.
