Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): March 4, 5 and 6, 2020.

The following intake was included as part of the inspection:

Log #002235-20\Complaint IL IL-74254-CW related to alleged staff to resident abuse.

During the course of the inspection, the inspector(s) spoke with the Administrator, Manager of Resident Care (MRC), Assistant Manager of Resident Care (AMRC), Registered Practical Nurses (RPN), Personal Support Workers (PSWs), residents and Substitute Decision Makers (SDMs).

A tour of the unit was completed as well as observations of staff to resident interactions, provision of care and general care and cleanliness of the home. A review of relevant records was completed.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 24. Reporting certain matters to Director

Specifically failed to comply with the following:

s. 24. (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:

- 1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 3. Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 4. Misuse or misappropriation of a resident's money. 2007, c. 8, s. 24 (1), 195 (2).**
- 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, s. 24 (1), 195 (2).**

Findings/Faits saillants :

1. The licensee has failed to ensure that the person who had reasonable grounds to suspect that abuse of a resident by staff had occurred, immediately reported the suspicion and the information upon which it was based to the Director.

A complaint was received to the Ministry of Long Term Care (MLTC), which alleged abuse of resident #001.

An email was sent to MRC #101 by PSW #102. It said the PSW wished to speak with the MRC the next day to report an incident of abuse. The MRC immediately spoke with PSW #102 and initiated an investigation into the allegation of abuse.

Administrator #100 and MRC #101 acknowledged they had not reported this incident to the Director.

The licensee failed to ensure that the person who had reasonable grounds to suspect that abuse of resident #001 by staff had occurred, immediately report the suspicion and the information upon which it was based to the Director. [s. 24. (1)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the person who had reasonable grounds to suspect that abuse of resident #001 or any other resident had occurred, immediately report the suspicion and the information upon which it was based to the Director, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 97. Notification re incidents

Specifically failed to comply with the following:

s. 97. (1) Every licensee of a long-term care home shall ensure that the resident's substitute decision-maker, if any, and any other person specified by the resident, (a) are notified immediately upon the licensee becoming aware of an alleged, suspected or witnessed incident of abuse or neglect of the resident that has resulted in a physical injury or pain to the resident or that causes distress to the resident that could potentially be detrimental to the resident's health or well-being; and (b) are notified within 12 hours upon the licensee becoming aware of any other alleged, suspected or witnessed incident of abuse or neglect of the resident. O. Reg. 79/10, s. 97 (1).

Findings/Faits saillants :

1. The licensee has failed to ensure that resident #001's Substitute Decision Maker (SDM), was notified within 12 hours upon becoming aware of alleged abuse of resident #001.

MRC #101 received an email from PSW #102 which stated that they wanted to speak with the MRC the next day, to report an incident of abuse that they witnessed two days earlier.

Administrator #100 and MRC #101 verified there was an alleged incident of abuse involving resident #001, reported to them by staff. MRC #101 acknowledged resident #001's SDM had not been notified of the allegation of abuse.

The licensee failed to ensure that resident #001's Substitute Decision Maker (SDM), was notified within 12 hours upon becoming aware of an allegation of abuse of resident #001. [s. 97. (1) (b)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the SDM is notified within 12 hours of becoming aware of an allegation of abuse of a resident, to be implemented voluntarily.
