Specifically failed to comply with the following:

- s. 12. (2) The licensee shall ensure that,
- (a) resident beds have a firm, comfortable mattress that is at least 10.16 centimetres thick unless contraindicated as set out in the resident's plan of care; O. Reg. 79/10, s. 12 (2).
- (b) resident beds are capable of being elevated at the head and have a headboard and a footboard; O. Reg. 79/10, s. 12 (2).
- (c) roll-away beds, day beds, double deck beds, or cots are not used as sleeping accommodation for a resident, except in an emergency; O. Reg. 79/10, s. 12 (2).
- (d) a bedside table is provided for every resident; O. Reg. 79/10, s. 12 (2).
- (e) a comfortable easy chair is provided for every resident in the resident's bedroom, or that a resident who wishes to provide their own comfortable easy chair is accommodated in doing so; and O. Reg. 79/10, s. 12 (2).
- (f) a clothes closet is provided for every resident in the resident's bedroom. O. Reg. 79/10, s. 12 (2).

Findings/Faits saillants:

1. The licensee failed to ensure that a comfortable easy chair is provided for every resident in the resident's bedroom, or that a resident who wishes to provide their own comfortable easy chair is accommodated in doing so.

On January 5, 2015 at 1330 hours it was observed in several ward rooms that there was only one office chair for the four residents in the room to sit on. Resident # 001 was sleeping in their bed, Resident # 002 was sitting up in their wheelchair sleeping, Resident # 003 was sleeping in their bed, and Resident # 004 was just returning to their room.

Upon interview with Resident # 003, and Resident # 004 they stated they would like to have a chair to sit on and would use it if were in the room. They declined providing their own chair.

Continued observations of several other ward rooms revealed that there were three rooms out of four rooms that did not have a comfortable easy chair for every resident.

Upon interview with Resident # 005 it was stated that if a chair were provided then they would use it. They declined providing their own chair.

Upon interview with the Environmental Services Manager January 5, 2015 at 1455 hours, it was confirmed that there should be one chair for every resident in the ward rooms. It was confirmed that the chairs are available in the home as he stated that he ordered extra for that reason alone. He felt they must have been moved out of the rooms over the holidays for social events. He confirmed he would replace the chairs in the ward rooms so every resident would have their own chair.
