This follow-up was required to determine compliance as a condition of the licence, after a licensee transfer on January 1, 2020.

**During the course of this inspection the following order was complied:
Pursuant to the LTCHA, 2007 S.O. 2007, c.8, s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).**

Order:

- a) In consultation with a registered dietitian who is a member of the staff of the home, education is to be provided to PSW #102 related to the identification of risks related to nutrition care and the implementation of interventions to mitigate and manage those risks. Education must include a review of where PSW #102 can find a resident's dietary plan of care to ensure they can easily reference a resident's diet texture conveniently and immediately.
- b) Ensure there is a documented record of the education provided and proof of attendance by PSW #102.
