The purpose of this inspection was to conduct a Critical Incident System inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, the Life Enrichment Director/Registered Practical Nurse, one Registered Nurse, one Registered Practical Nurse, two Personal Support Workers, one Maintenance worker, one Housekeeper, one COVID-19 Screener and one resident.
