The purpose of this inspection was to conduct a Critical Incident System inspection.

During the course of the inspection, the inspector(s) spoke with the Executive Director, the Director of Care (DOC), the Associate Directors of Care (ADOCs), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs) and Housekeeping staff.

During the course of the inspection, the inspector observed resident and staff interactions, and infection prevention and control practices. They reviewed clinical health records, relevant home policies and procedures, and other pertinent documents.
