The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): October 2 and 8, 2015.

This Critical Incident Inspection was conducted related to falls and pain management.

During the course of the inspection, the inspector(s) spoke with the assistant Director of Nursing, the physiotherapist, the physiotherapist assistant, the nurse lead outreach team registered nurse, registered nursing staff, personal support workers and the resident.

During the course of the inspection the inspector reviewed the clinical record, observed the provision of care and services and reviewed relevant policies and procedures.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 50. Skin and wound care



Specifically failed to comply with the following:

s. 50. (2) Every licensee of a long-term care home shall ensure that,

(a) a resident at risk of altered skin integrity receives a skin assessment by a member of the registered nursing staff,

(i) within 24 hours of the resident's admission,

(ii) upon any return of the resident from hospital, and

(iii) upon any return of the resident from an absence of greater than 24 hours; O. Reg. 79/10, s. 50 (2).

(b) a resident exhibiting altered skin integrity, including skin breakdown, pressure ulcers, skin tears or wounds,

(i) receives a skin assessment by a member of the registered nursing staff, using a clinically appropriate assessment instrument that is specifically designed for skin and wound assessment,

(ii) receives immediate treatment and interventions to reduce or relieve pain, promote healing, and prevent infection, as required,

(iii) is assessed by a registered dietitian who is a member of the staff of the home, and any changes made to the resident's plan of care relating to nutrition and hydration are implemented, and

(iv) is reassessed at least weekly by a member of the registered nursing staff, if clinically indicated; O. Reg. 79/10, s. 50 (2).

(c) the equipment, supplies, devices and positioning aids referred to in subsection (1) are readily available at the home as required to relieve pressure, treat pressure ulcers, skin tears or wounds and promote healing; and O. Reg. 79/10, s. 50 (2).

(d) any resident who is dependent on staff for repositioning is repositioned every two hours or more frequently as required depending upon the resident's condition and tolerance of tissue load, except that a resident shall only be repositioned while asleep if clinically indicated. O. Reg. 79/10, s. 50 (2).

1. The licensee failed ensure that the resident at risk of altered skin integrity received a skin assessment upon any return of the resident from the hospital.

In September 2015, resident #20 was transferred to the hospital, following an injury and was readmitted back to the home four days later. A review of the clinical record identified that on return from hospital the resident was required to spend an extended period of time in bed. The clinical record did not include a skin assessment of the resident on return from the hospital. Interview with the registered staff who readmitted to resident confirmed that a skin assessment was not completed on readmission after she reviewed the clinical record. [s. 50. (2)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that residents receive a skin assessment upon any return from the hospital, to be implemented voluntarily.
