The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): January 14, 15, 16, 17 and 20, 2020.

Sarah Inglis #767 was also present during this inspection.

During this Critical Incident System Inspection, log number 021808-19 was completed regarding a fall with injury for which a resident was taken to hospital and resulted in a significant change in the resident's health status.

This inspection was done concurrently with a complaint inspection (inspection number 2020_773155_0001).

During the course of the inspection, the inspector(s) spoke with the Director of Care, RAI Coordinator/Associate Director of Care, Registered Practical Nurses, Physiotherapy Assistant, Personal Support Workers and resident.

The inspectors also toured the home; reviewed relevant clinical records; observed falls prevention equipment and observed resident-staff interactions.
