The purpose of this inspection was to conduct a Director Order Follow Up inspection.

This inspection was conducted on the following date(s): January 31, February 1, 2 and 3, 2022.

Log #000871-22, follow up to Director Order (DO) # 001 from inspection #2021_890758_0018, regarding s. 229 (4), with a Compliance Due Date (CDD) of January 21, 2022.

Critical Incident System Inspection #2022_729615_0005 was completed in conjunction with this inspection.

During the course of the inspection, the inspector(s) spoke with the Regional Vice President, the Executive Director, the Director of Care, the Associate Director of Care - Infection Prevention and Control Lead, a Registered Nurse, a Registered Practical Nurse, four Personal Support Workers, the Scheduler and residents.

A follow up inspection to a Director Order (DO#001 served on 2022-01-12) concluded that the Director Order was complied with (r. 229. (4)).

The inspector(s) also toured the home, observed staff to resident interactions, meal services and Infection Prevention and Control (IPAC) practices, reviewed residents' clinical records, the home's IPAC policies and procedures, and other relevant documents.
