WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 31. Nursing and personal support services

Specifically failed to comply with the following:

s. 31. (4) The licensee shall keep a written record relating to each evaluation under clause (3) (e) that includes the date of the evaluation, the names of the persons who participated in the evaluation, a summary of the changes made and the date that those changes were implemented. O. Reg. 79/10, s. 31 (4).

Findings/Faits saillants :

1. The licensee has failed to ensure that there is a written record of each annual evaluation of the staffing plan including the date of the evaluation, the names of the persons who participated in the evaluation, a summary of the changes made and the date that those changes were implemented.

On an identified date, a complaint was submitted to the Ministry of Health and Long-Term Care (MOHLTC) InfoLine related to sufficient staffing. The complainant stated that the home was very short staff which affect the resident care.

Review of the home's staffing plan failed to reveal a written annual evaluation.

In an interview, staff #112 stated that the home's staffing plan had been reviewed as part of the annual budget discussion and had not been documented. He/she confirmed that a written record was not available. [s. 31. (4)]
