During the course of the inspection, the inspector(s) spoke with Residents, Personal Support Workers (PSWs), a Registered Practical Nurse (RPN), Registered Nurses (RNs), Assistant Director of Care (ADOC), and the Executive Director.

The inspector also reviewed policies, plans of care and other documentation within the home, conducted a daily walk through of the resident care areas, observed staff to resident interactions and the delivery of care and services to the residents.
