the non-compliance met the intent of section 154 (2) and requires no further action.

The licensee has failed to ensure that the Infection Prevention and Control (IPAC) Standard for Long-Term Care Homes issued by the Director was complied with.

In accordance with Additional Requirement 11.6 under the IPAC Standard for Long-Term Care Homes (April 2022, revised September 2023), the home was required to post signage at entrances and throughout the home that lists the signs and symptoms of infectious diseases for self-monitoring as well as steps that must be taken if an infectious disease is suspected or confirmed in any individual.

An observation revealed that the entrance to the 3A resident unit did not have signage posted that noted the signs and symptoms of infectious diseases for selfmonitoring as well as steps that must be taken if an infectious disease was identified. After the inspector brought it to the home's attention, the home posted the required signage.
