WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 3. Residents' Bill of Rights

Specifically failed to comply with the following:

s. 3. (1) Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:
4. Every resident has the right to be properly sheltered, fed, clothed, groomed and cared for in a manner consistent with his or her needs. 2007, c. 8, s. 3 (1).

## Findings/Faits saillants :

1. The licensee failed to ensure that every resident's right to be properly fed and cared for in a manner consistent with his or her needs is fully respected and promoted. Resident #1 and #2's spiritual and religious need for cultural foods was not fully respected and promoted.

Interviews with the FSM, social worker and DOC confirmed that the home does not prepare cultural meals and does not offer cultural foods to be brought in. The home's admission package states that "if you wish to have cultural meals, the home will provide you with recommendations to other facilities".

Record review revealed that resident #1 was admitted to Leisureworld Richmond Hill on a specified date, and was identified as being of a specified faith. Resident #1's plan of care identifies him/her as being at nutritional risk due to multiple food preferences and food restrictions due to religion. Interview with resident #1 revealed that he/she needs to eat cultural food in order to observe his/her religious beliefs.

Record review revealed that resident #2 was admitted to Leisureworld Richmond Hill on a specified date, and was identified as being of a specified faith. Interview with resident #2 revealed that he/she observed their religion most of his/her life because his/her spouse was from a very religious family. He/she stated that sometimes his/her children will bring in cultural foods that they know he/she likes. He/she also stated that he/she does not eat meat at this home because it makes him/her lose his appetite. [s. 3. (1) 4.]

WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

s. 6. (2) The licensee shall ensure that the care set out in the plan of care is based on an assessment of the resident and the needs and preferences of that resident. 2007, c. 8, s. 6 (2).

1. The licensee has failed to ensure that the plan of care is based on an assessment of the resident and the resident's needs and preferences.

Record review revealed that resident #1 was admitted to Leisureworld Richmond Hill on a specified date, and was identified as being of a specified faith. Resident #1's plan of care identifies him/her as being at nutritional risk due to multiple food preferences and food restrictions due to religion.

Interview with resident #1 revealed that he/she would prefer to eat cultural foods if given the choice. He/she stated that he/she is able to switch food items around with the different choices so that meat and dairy are not served at the same meal and follows a no pork diet intervention. He/she also stated he/she would feel better if he/she ate cultural foods.

Record review revealed that resident #2 was admitted to Leisureworld Richmond Hill on a specified date, and was identified as being of a specified faith. Resident #2's plan of care identifies him/her as being at nutritional risk due to varied oral intake at meals and low body weight.

Interview with resident #2 revealed that he/she observed their religion most of his/her life because his/her spouse was from a very religious family. He/she stated that sometimes his/her children will bring in cultural foods that they know he/she likes. He/she also stated that he/she does not eat meat at this home because it makes him/her lose his/her appetite. He/she stated if he/she had a choice he/she would prefer to eat cultural foods all the time and thinks he/she would definitely eat better and include more meat in his/her diet.

Interviews with the FSM and RD confirmed that the home has not assessed residents #1's and #2's need to observe their religion by eating cultural food. [s. 6. (2)]
