**During the course of the inspection, the inspector(s) spoke with the Executive Director (ED), Office Manager, Medical Director, Registered Dietitian (RD), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Director of Environment, Director of Food Services, residents, substitute decision makers (SDMs) and family members of residents.**
