Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 229. Infection prevention and control program**

**Specifically failed to comply with the following:**

**s. 229. (4) The licensee shall ensure that all staff participate in the implementation of the program. O. Reg. 79/10, s. 229 (4).**

**Findings/Faits saillants :**

1. Housekeeping staff on an identified resident home area was observed to clean an isolated resident room to a non-isolated room without changing use of cleaning products, bucket solution. [s. 229. (4)]
2. A housekeeper on an identified resident home area did not use a high level disinfectant on high contact surfaces in identified resident rooms designated for isolation precautions allowing for the potential spread of infection of antimicrobial resistant organisms. [s. 229. (4)]
3. Review of the home's cleaning policy of resident rooms on isolation indicated that these rooms are to be cleaned last in the afternoon following daily clean of all other resident rooms. [s. 229. (4)]
